

## ***EESS SAFE GRAD 2020 RULES AND REGULATIONS***

In order to provide a safe environment for the Graduates to celebrate, parent(s)/guardian(s) are responsible for ensuring that the Safe Grad rules and regulations as outlined below are followed by the Grad, guests, and family members for the Safe Grad 2020 event on June 24, 2020.

1. Grads must submit their approved lists of party guests and payment(s) for themselves and guests by the deadline of May 15, 2020 in order to secure space for themselves and their guests at Safe Grad 2020.
2. Parents/Guardians/Designates of Grads are not permitted to drink alcohol at the Safe Grad event. Each Grad must have two parents/guardians/Designates on their guest list that will not be consuming alcohol during the Grad 2020 evening and are then responsible for driving their Grad and his/her guests' home.
3. The Safe Grad event will begin with doors opening at 11 p.m. Last call for liquor ticket sales will be at 2:00 a.m., ticket sales will end at 2:30 a.m., last call for the bar will be at 2:30 a.m. and the bar will close at 3:00 a.m. Drinks are required to be off the table and event ends at 4:00 a.m.
4. No one will be permitted to enter the Safe Grad event after 1:00 a.m.
5. Admission to Safe Grad 2020 is limited to the Grads and their invited guests, No one will be allowed into the party without their name being on the approved guest list, held by Security at the entrance, from which attendees are checked-in to the event. Approved means the guest list signed by the Grad's parent/guardian and a signed Safe Grad Committee 2020 Release Form has been submitted along with payment for the event.
6. All Grads and guests must produce photo ID to gain entrance and will be given an appropriate wrist band upon entrance. Only those wearing "over 18" wristbands may purchase alcohol. Parent supervisors may refuse to serve anyone who has "had too much to drink."
7. Guests must be between the ages of 16 and 20, on the day of entrance to the Safe Grad event. \*Exception will be provided for a sibling and/or Grad date that has attended the graduation dinner and dance. Either must be approved by the Safe Grad Executive Committee.
8. Grads and their parents are responsible for the behaviour of their guests and themselves. If a Grad leaves, all of his/her guests must also leave. If a guest leaves, the Grad may stay.
9. All liquor permit conditions will be followed. No one will be allowed to possess/purchase more than two drinks at a time.
10. Any guests who leave will not be permitted to re-enter the Safe Grad event.
11. No alcohol or drugs (legal or illicit), are allowed to be brought into the Safe Grad event. Bags will be searched. Consuming/using drugs or illegally brought in alcohol will result in the offender being sent home.
12. Any person involved in a fight, or any other aggressive physical contact, will be escorted home. RCMP may be contacted to assist as necessary.
13. It is essential that no parents/guardians allow an alcohol party to be planned, or attended by their Grad, before or after the Safe Grad event on June 24, 2020. This negates the whole purpose of hosting a Safe Grad function.
14. The Safe Grad Committee will plan the Safe Grad event but will not be held liable. All parents of all Grads in attendance are responsible to maintain as safe a Graduation as possible.
